Sheridan said he finally spoke to Allen asking "Do you need something?" Sheridan stated that there was no further interaction.

Mario Bouchard provided a written statement saying that he observed Allen in the "Smith's" backyard around the time of the incident.

Original Write-Up

Allen came to station to report being harassed by the neighbor across the alley, Sheridan. There has been trouble between them for approximately 3 years. Today Allen was in another neighbors yard cutting up a tree. He had his 5 years old son with him. Allen said he was just looking across the alley at nothing in particular and Sheridan yelled something at Allen. Allen believes it was directed at him because when he looked in the direction, Sheridan was looking at him. Allen doesn't know what was said but it was an angry tone of voice. Allen didn't say anything back because there is a no contact order against Allen for Sheridan from a previous complaint. (Allen is on probation). Prior detective was D/Sgt. Lance.

Beginning at 3:30 PM on Wednesday 25 August 2004, I was working on and in my garage, which is adjacent to my home located at 22357 Columbia Street in Dearborn. At approximately 5:00 PM I became aware of someone shooting very loudly, in a violent tone, and using extensive profanity. At first I was uncertain as to the identity of person because I was inside my garage, and did not intending to investigate or interfere in the matter. It then became obvious that the person screaming and yelling was in-fact Larry Allen, who resides at 22372 Oxford Street. I heard a car door slamming, which seemed to have come from the black Land Rover I have seen driven by Allen. As Allen continued to scream and shoot, I distinctly heard him say the following statements, "What the fuck are you doing!?", and "What the fuck is wrong with you!?", and "Tell me what the fuck I should do; tell me!?", and "Get the fuck over here!" Allen's shouting was loud enough to be heard throughout the local neighborhood. Because I was not in eye-shot of Allen, I did not know who or whom he was shouting at, and could only speculate. However, from inside my garage I then noted that Allen's two small children were cowering in fear as they were being directed by Allen to enter their house through the side door entrance. Allen was wearing what appeared to be a full nurse uniform, green in color. The two little children appeared to be wearing bathing suits. When I realized that the cursing and threatening statements recounted above were directed at these small children by Allen, I became deeply concerned for their well-being and safety. During that moment of concern and utter revulsion I did stand motionless in my garage observing Allen. While holding the door open for the children with his left hand, and when he then observed my witnessing of his shouting and cursing, Allen immediately raised his right hand in my direction gesturing me with his middle-finger. Very shortly thereafter, I observed Allen walking around in the backyard of his next door neighbor, Mrs. Smith who lives at 22364 Oxford Street. I did not and was not inclined to determine the purpose of Allen's presence on the Smith property. I then heard my next door neighbor, Mr. Mario Bouchard in his backyard, which is located at 22351 Columbia Street. I immediately recounted the above details, regarding Allen's screaming and cursing at the little children, to Mr. Bouchard, emphasizing my concern for the safety of the Allen children. This recounting occurred at approximately 5:30 PM. While I recounted my witnessing to Mr. Bouchard, Allen was positioned behind bushes in the Smith backyard, and was observing Mr. Bouchard and I conversing. When Mr. Bouchard and I concluded, Mr. Bouchard returned into his house, and I went to my basement to retrieve tools which I needed to continue working on the outside of my garage. When I returned to the garage Allen was now positioned out from behind the bushes, and closer to the Smith fence which abuts the driveway alley which is used by myself and the Bouchards. Allen stood for an extended period of time scanning and straining to see the contents of my garage through the open car garage door which abuts the same driveway alley. I observed Allen proceeding in this "casing" mode for several minutes. At first he was not aware of my return from the basement. After several

minutes I calmly but clearly, and with sufficient volume, asked Allen, "Do you need something?" It was very clear to me that Allen heard and understood my words. I asked this question at approximately 5:45 PM. At this moment, Allen receded from view, and their was no further interaction between us on Wednesday 25 August 2004.

Up to Wednesday 25 August 2004 I have observed Allen performing carpentry work. During the time of this work, large scraps of discarded wood have been dumped into the driveway alley which is used exclusively by the Bouchards and I. Also, dumped into the driveway alley are large quantities of sawdust. Prior to my observation of Allen performing carpentry work, no scrap wood or sawdust has ever been dumped by anyone in the driveway alley, during the 23 years I have used it.

Prior to the events above, on or about Wednesday 11 August while driving westbound on Oxford Street and stopping at the intersection at Pardee, Allen came out of his house, cleared his throat in a loud exaggerated sound, and spit at my car. Allen's sputum did not hit me or my vehicle. This is a recurring behavior of Allen, which I had reported to the Dearborn Police earlier. As before in prior instances, I did not confront Allen on his spitting of Wednesday 11 August.

At approximately 5:30 PM on Wednesday 25 August 2004 I entered my backyard which is located at 22351 Columbia Street in Dearborn. I observed my next door neighbor Mr. Paul Sheridan of 22357 Columbia Street working on his garage. It was clear to me from the facial expression that I observed on Mr. Sheridan, that he was troubled or concerned. I have been fortunate to live next to Mr. Sheridan for approximately 17 years and have come to know him well. When I greeted Mr. Sheridan at the fence between our properties he reviewed with me in detail what he had just observed. Mr. Sheridan explained in detail the yelling and cursing of Larry Allen who resides at 22372 Oxford Street. Mr. Sheridan explained that his primary concern was for the children of Allen. During the time that Mr. Sheridan was reviewing the cursing of Allen at his children, Allen was in the backyard of the Smith residence at 22364 Oxford Street. I did not have any interaction with Allen during Wednesday 25 August 2004.

I have recently observed Allen performing carpentry work. During the time of this work large scraps of discarded wood have been dumped into the driveway alley which is used exclusively by myself and Mr. Sheridan. Also, dumped into the driveway alley are large quantities of sawdust. I personally took the time to photograph these piles of scrap wood and sawdust. I also took the time to clean up the scraps of wood, because these scraps were both unsightly and posed a safety hazard. A portion of the dumped sawdust remains as of this writing. Prior to my observation of Allen performing carpentry work, no scrap wood or sawdust has ever been dumped by anyone in the driveway alley during the 17 years I have used it.
