My letter to you of 29 April 2015 very specifically explains that the 'People of California' have been victimized by crimes. I identified the 'People of California' involved: the brothers Magdaleno and Raymundo Sanchez were victims of crimes in Los Angeles, California.

At no time do I ask for your assistance with crimes committed in Dearborn, Michigan (!?). Reference 2 spews "seek assistance from your local authorities." The Sanchez brothers were not victims of crimes in Dearborn, Michigan. My letter to you of 29 April states:

"Please note that the first page lists the Chavez Law Group, the California law firm representing the Sanchez brothers, Magdaleno and Raymundo. Please note Page 1 depicts the Sanchez Jeep burning on the 110 Freeway in Los Angeles on the evening of April 3, 2014."

The Chavez Law Group is pursuing the civil matter (in California) in behalf of the Sanchez brothers.

I requested that you pursue the <u>criminal</u> matter in their behalf in the context of your job as Attorney General <u>of CALIFORNIA</u>. I am returning the materials previously sent, as well as the webpage quoted above.



Dear Madam Attorney General Harris:

Attachment 1 is the jury verdict form from the fire-death trial of a 4-year-old boy, Remington Walden. Signed on April 2, 2015, the jury had unanimously assigned the following "percentage of fault for each defendant":

Driver of the vehicle that collided with the Jeep wherein Remington was a rear-seat passenger: 1% Fiat-Chrysler Automotive (FCA), the group that designed/profited from sale of defective Jeeps: 99%

Attachment 2 is a press release relating to the Walden verdict; please note it discusses the "Baker memo."

Attachment 3 was sent to Center for Auto Safety (CAS) Director Clarence Ditlow on February 12, 2015. Note that Attachment 3 called for a criminal investigation regarding these matters three months prior to the "percentage of fault for each defendant" jury determination in Walden v FCA.

Attachment 4 was sent to CAS on August 20, 2014. Note that I had called for a criminal investigation of these matters <u>eight months</u> prior to the "percentage of fault" jury determination in Walden. Please note that the first page lists the Chavez Law Group, the California law firm representing the Sanchez brothers, Magdaleno and Raymundo. Please note Page 1 depicts the Sanchez Jeep burning on the 110 Freeway in Los Angeles on the evening of April 3, 2014.

Michigan Attorney General Bill Schuette received Attachment 5 on April 24, 2015. The severe injury to the Sanchez Brothers is detailed on Page 3. My suggestion is, as a primer for the Subject, please review Attachment 5 (and its many hyperlinked references), especially Pages 13 and 14.

Paraphrasing Attachment 5 page 29: I am confident that when a grand jury is convened <u>in California</u> for the purposes of a criminal investigation of the severe injury to the Sanchez Brothers, the members will assess that FCA and NHTSA/DOT acted in a manner that made it:

"... not improbable that injury will be occasioned, and the offender knows, or is charged with the knowledge of, the probable result of his acts."
