Dear Congressman Wexler:

Thank you very much for executing your Constitutional duty to effect check-n-balance oversight of the Executive branch. I say this specifically because I was recently told by a senior member of the Senate that Congress plays no such role. I was rebuffed during a telephone conversation by a senior member of that senator's staff who declared that "Congress is not here to second guess the other branches."

I sincerely applaud your requirement that ex White House Press Secretary Scott McClellan testify before the House Judiciary Committee. The focus of your demand includes the issue of the criminal outing of Valerie Plame by the White House following the reports by former Ambassador Joe Wilson.

But when he was forced to concede that the truthful uranium reports had motivated the White House to attack Wilson, Shays blurted the following: 'The bottom line was, it wasn't what the White House may have wanted to hear or what I wanted to hear.' "

In this context I encourage you to subpoena Rep. Shays to the House Judiciary Committee, place him under oath, and provide him with the opportunity to dutifully explain his quote on *Larry King Live*; a quote which occurred PRIOR to the then-unexpected Judge Hogan ruling of August 10, 2004 to proceed with the Wilson/Plame trial.

Was this statement merely a mistake, as some now claim? Or was the "slam dunk" the

result of a fundamental incompetence of the current commander-in-chief?

It was then not uncommon for the staff to interpret the boss's proclamation as marching orders.
	I sometimes got into hot water when I stated facts that my bosses "did not want to hear."
	I am not alone in this context.
	Former U.S. Ambassador Joe Wilson was guilty of presenting facts that were not consistent with his bosses' marching orders. His bosses were George W. Bush and Dick Cheney.
	In Wilson's case the White House had already decided that it was going to war against Iraq. Their crucial proclamation was Hussein's alleged possession of weapons of mass destruction, especially nuclear weapons. In early 2002, when British intelligence claimed that Hussein was purchasing uranium for use in nuclear warheads, Wilson was dispatched to the region to confirm the facts.
	Unfortunately, Wilson never got the message about which facts the White House wanted to hear, and which facts would get him into hot water. His reports to the White House refuted the British allegations about Saddam and uranium.
