Enclosed please find the Cashier's Check dated November 29, 2016 that was sent to my client, Mr. Paul Sheridan. The check is being returned to you as my client has declined its acceptance. We wish to reiterate our demand for retraction and apology submitted on behalf of Mr. Paul V. Sheridan in regards to the false and defamatory statements you have made about him. Attached please find a copy of our original Demand Letter dated November 18, 2016.

Once more, Demand is hereby made upon both of you and Mrs. Bouchard to issue a full and complete retraction, in writing, and an apology to Mr. Sheridan for having made these false and defamatory statements. These statements have damaged Mr. Sheridan's reputation, as well as caused him great consternation that you would damage his reputation which he has worked for many, many years to earn, create and maintain, and which is of particular importance to him and the people he serves in his highly esteemed profession. 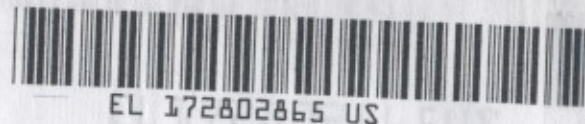


