**Subject : FullMeasure Candidate Interview Series – LIABILITY IMMUNITY**

Thank you for your recent Subject interview with presidential candidate Mr. Vivek Ramaswamy:



Attached is an anonymous note, allegedly from the Trump Organization. I discuss at-length with Ms. Kimberly Cheatle, Director of the US Secret Service; under Tab 4 of the enclosed binder (as Reference 6). The signed-for courtesy recipients of the enclosed letter/binder to Congresswomen Mace and Luna, and Congressman Jordan, are listed on Page 21 of 22.

**PLEASE NOTE TAB 5.** On Pages 5 thru 8 I present portions of the Mrs. Jummai Nache medical report. At-bottom of Page 7, I quote an indicative statement of that report:

*“Most of our visit was spent again discussing the potential role of the vaccine in this process. Dr. Fontana shared the letter from the CDC stating that this was MIS-A without clear involvement from the vaccine, though it can't (and likely never will be) excluded as contributing to some extent.”*

**Some extent?!** Or is this a KNOWN outcome. We examine details in the recent FOIA-enforced Pfizer “2020 vaccine trials” disclosures regarding Subject #10841470 . . . screenshot:

Subject # 10841470 is an obese 65-year-old Hispanic male with a medical history including pulmonary fibrosis and hypertension. He was in the Placebo arm of the trial and received Doses 1 and 2 on September 30 and October 21, 2020, respectively. On December 23, 2020, the subject received Dose 1 of the Moderna mRNA vaccine. This Protocol Deviation was reported in his CRF after the subject reported symptoms of COVID-19 on December 28, 2020 and was admitted to the hospital on December 31, 2020. While hospitalized, he became hypoxic and was intubated on January 2, 2021. He received monoclonal antibodies as part of his treatment in the hospital. Despite these efforts, the subject continued to deteriorate, lapsed into multisystem organ failure, and ultimately died on January 11, 2021. Subject #10841470 was in the List of Discontinued Subjects [10] as a “Death” and in the 6-Month Interim Report [8] as a Placebo death with COVID-19 as the secondary cause of death. This is a misrepresentation of the subject’s clinical information. The subject should have been discontinued from the Pfizer/BioNTech clinical trial because the “subject received non-study COVID-19 vaccine”.

**Connection:** Throughout 2020, while working with “COVID positive” patients at the University of Minnesota, Mrs. Jummai Nache had ZERO symptoms. After the second Pfizer modRNA injection, Jummai collapsed in agony but, unlike Subject #10841470 , survived. The connection involves the stark fact that only *AFTER* receiving the modRNA needle did either “test positive for COVID” !
