**Subject :** ORDER DIRECTING IMPANELMENT OF A STATEWIDE COVID GRAND JURY, CASE NUMBER SC22-1710 (THURSDAY, DECEMBER 22, 2022)

**Dear Governor DeSantis / Dear Ms. Neely :**

I am re-forwarding to you the letter of [Reference 1](#); to include the shipper SPODs indicating your receipt, and for correction to a typographical error on Page 2 of 2.

On Page 2 of 2 of [Reference 1](#) I proposed four preliminary witnesses for the Subject; one of which is the esteemed Dr. Michael Yeadon:



**MEMO :** This is not my first mentioning of Dr. Yeadon in COVID-19 materials/correspondence; hardly. As just one example, [in my 12 April 2021 letter](#) addressed to “America’s Doctor,” Mr. Anthony Fauci, I spend twenty-six pages detailing the Nuremburg Tribunals, and the direct Fauci role in ensuring that ‘informed consent’ was avoided, especially by those ostensibly protected from liability under the PREP Act; I discuss Dr. Yeadon and his early foray into, what is now, a key element of the Subject: **Criminality**. From the Subject order (emphasis added, screenshot):

(a) Individuals, persons, and entities, including, but not limited to, pharmaceutical manufacturers (and their executive officers) and other medical associations or organizations involved in the design, development, clinical testing or investigation, manufacture, marketing, representation, advertising, promotion, labeling, distribution, formulation, packing, sale, purchase, donation, dispensing, prescribing, administration, or use of vaccines purported to prevent COVID-19 infection, symptoms, and transmission;

(b) other **criminal activity** or wrongdoing that the statewide grand jury uncovers during the course of the investigation if it determines that pursuing the **criminal** activity or wrongdoing is in the best interests of the investigation;

and

(2) is occurring, or has occurred, in two or more judicial circuits as part of a related transaction or is connected with an organized **criminal** conspiracy affecting two or more judicial circuits, as required by section 905.34, Florida Statutes.

Regarding [Reference 1](#) and the *Witness List Rationale Review*: (1) Mr. Edward Dowd, (2) Dr. David Martin (3) Ms. Catherine Watt and (4) Dr. Michael Yeadon . . . Mr. Dowd and his expertise are directly connectable and relevant to the efforts of co-addressee [Ms. Susan Neely at the ACLI](#).

The expertise of proposed witnesses (2), (3) and (4) are directly connectable to the verbiage of the Court’s order above. Indeed, a key element to attaining much-needed justice for the “COVID vaccine” injured and killed is the voiding of the LIABILITY IMMUNITY provisions so-strenuously promoted and enforced by entities ranging from Ivy League presidents, to Mr. Anthony Fauci, to Mr. Albert Bourla, to Mr. Joe Biden.

### What You Need to Know

- If you are a non-U.S. citizen who is a nonimmigrant (not a U.S. citizen, U.S. national, lawful permanent resident, or traveling to the United States on an immigrant visa), you will need to show proof of being fully vaccinated against COVID-19 before you travel by air to the United States from a foreign country.
- Some categories of noncitizen, nonimmigrants are excepted from this requirement. If you meet the criteria for one of these categories, you will need to fulfill additional requirements to travel by air to the United States.

I am forwarding to you, for information and potential utility to **Reference 1**, a complete hard-copy duplicate of the 18 April 2022 ten-tab letter previously shared with Ms. Susan Neely, CEO of the American Council of Life Insurers. Note that the SPOD indicates Ms. Neely receipt of 20 April 2022.

I am also forwarding **Reference 2**; a sample of many previously/currently being sent to fellow governors. Note that I highlight/praise ¶ B-1-a of the Court's order. The most disheartening, and primary in terms of instant Subject justification, is the section in my letter to the governors which begins on Page 3 of 5 :

## **Blood Transfusion / mRNA Induced Death of Baby Alex**

That section is preambled on Page 2 (screenshot):

**Pre-planned Underbelly of COVID-19 Criminal Enterprise is *Liability Immunity***

I have asked *many* times :
