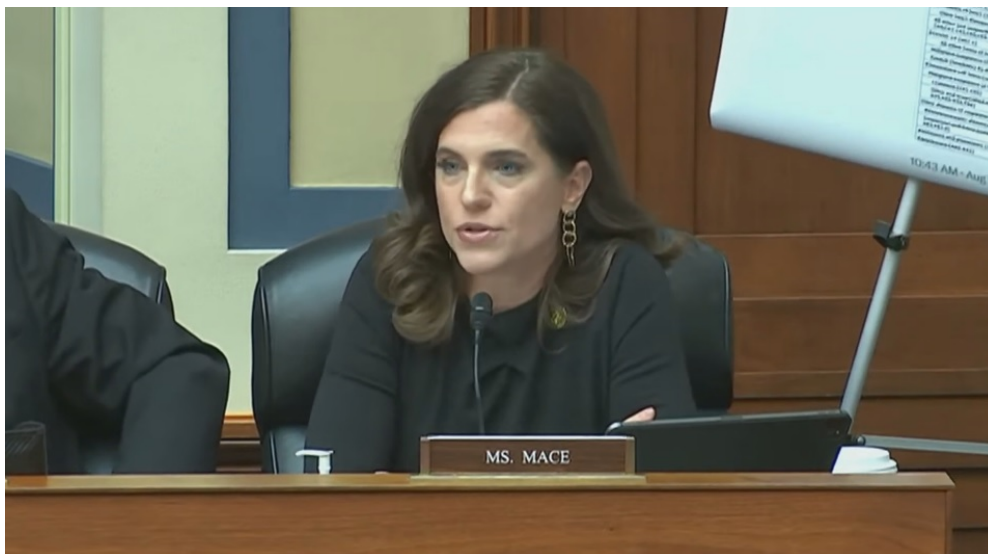

Thank you Mr. Chairman.

The Twitter files were not just about Hunter Biden's laptop. Twitter files make it apparent **Twitter worked overtime to suppress accurate COVID information.**

Dr. Jay Bhattacharya is a professor of medicine at Stanford (University) who once tweeted an article where he wrote about natural immunity. Thanks to Elon Musk's release of the Twitter files, we learned that some of his (Jay's) tweets were tagged with the label of 'Trends Blacklist.' Apparently the views of a Stanford doctor are 'disinformation' to you people.

**I, along with many Americans, have long-term effects from COVID. Not only was I a long-hauler, but I have effects from the vaccine; it was not the first shot, but it was the second shot that I now developed asthma, that has never gone-away since I had the second shot. I have tremors in my left hand, and I have the occasional heart pain that no doctor can explain, and I have had a battery of tests.**

I find it extremely alarming Twitter's unfettered censorship spread into medical fields, and affected millions of Americans by suppressing expert opinions from doctors, and censoring those who disagree with the CDC.

**I have great regrets about getting the shots because of the health issues that I now have that I do not think are ever going to go-away. And I know that I am not the only American who has those kinds of concerns.**

Another example of what Twitter has done to censor folks is from Dr. Martin Kulldorff, a Harvard educated epidemiologist who once tweeted:

*"COVID vaccines are important for high risk people and their caretakers. Those with prior natural infection do not need it, nor children."*

The Twitter files reveal this tweet was deemed 'false information' because it ran contrary to the CDC. So my first question this morning of Ms. Gadde, may I ask of you, where did you go to medical school?

Ms. Gadde: *I did not go to medical school.*

Rep. Mace: I'm sorry?

Ms. Gadde: *I did not go to medical school.*

- Rep. Mace:            Why do you think that you, or anyone else at Twitter, had the medical expertise to censor a doctor's expert opinion?
- Ms. Gadde:            *Our policies regarding COVID were designed to protect individuals. We were seeing . . .*
- Rep. Mace:            "You guys censored Harvard educated doctors, Stanford educated doctors; doctors that are educated in the best places in the world, and you silenced those voices!"
- My next question is, 'Did the U.S. government,' excuse me, I have another chart I want to show you Ms. Gadde. I have another Tweet from someone with a following of a full eighteen thousand followers. This person put a chart from the CDC on Twitter. It is the CDC's own data, so it is accurate by your standards. And you all labeled this as 'misleading.' You are not a doctor, right Ms. Gadde?
- Ms. Gadde:            *No I'm not.*
- Rep. Mace:            What makes you think that you or anyone else of Twitter have the medical expertise to censor actual accurate CDC data?
- Ms. Gadde:            *I'm not familiar with these particular situations.*
- Rep. Mace:            Yeah, I am sure you are not, but this is what Twitter did, they labeled this (CDC chart) as 'inaccurate.' It is the government's own data. It is ridiculous that we are even having to have this conversation. It is not just about the laptop, this is about medical advice that expert doctors were trying to give to Americans because social media companies like Twitter were silencing their voices.
- I have another question, my last one for you Ms. Gadde. Did the U.S. government ever contact you, or anyone at Twitter, to pressure Twitter to moderate or censor certain tweets; yes or no?
- Ms. Gadde:            *We have a program . . .*
- Rep. Mace:            Did the U.S. government ever contact you, or anyone at Twitter, to censor or moderate certain tweets; yes or no?!
- Ms. Gadde:            *We received legal demands to remove content from the platform from the U.S. government and the governments all around the world. Those are published on a third party website, and anyone can review . . ."*

**Twitter Witness Examination by Congresswoman Nancy Mace (R-SC) – 8 February 2023 Conclusion**

Rep. Mace: Thank God for Matt Tiabbi, thank God for Elon Musk, for allowing to show us in the world that Twitter was basically a subsidiary of the FBI, censoring real medical voices with real expertise that put real American lives in danger because they did not have that information. I also want to thank one of my colleagues Ro Khanna, because as it turns out censorship is not just an important issue to conservatives. Some of my colleagues on the other side of the aisle, like Ro found this censorship very concerning, and even wrote to you and the folks at Twitter that **he was concerned about the First Amendment being censored**. On Page 1 of Reference 1 you stated (screenshot):

As safe and effective vaccines become available, the end of this pandemic is in sight. This end, however, depends on the widespread acceptance of these vaccines as safe and effective. Unfortunately, misinformation disseminated via your platforms has increased vaccine hesitancy, which will slow economic recovery and, more importantly, ultimately cause even more unnecessary deaths. A small group of individuals use your platforms to downplay the dangers of COVID-19 and spread misinformation about the safety of vaccines. These individuals lack medical expertise and are often motivated by financial interests. According to a recent report by the Center for Countering Digital Hate<sup>1</sup>, so-called “anti-vaxxer” accounts on Facebook, YouTube, Instagram, and Twitter reach more than 59 million followers. “Anti-vaxxers” are using social media platforms to target people of color and Black Americans specifically, members of communities who have suffered the worst health impacts of the virus and whose vaccination rates are lagging.

Lack medical expertise? Motivated by financial interests?! Your entire letter is anti-Constitutional but most revealing of you, Mr. Ellison. Unlike the other AG signatories, you were already fully aware of the mRNA injuries that had **already** occurred, and had been documented by Pfizer . . . **right there in Minnesota.**

*What has caused this historic spike in deaths among younger people?*

*What has caused the shift from old people, who are expected to die, to younger people, who are expected to keep living?*

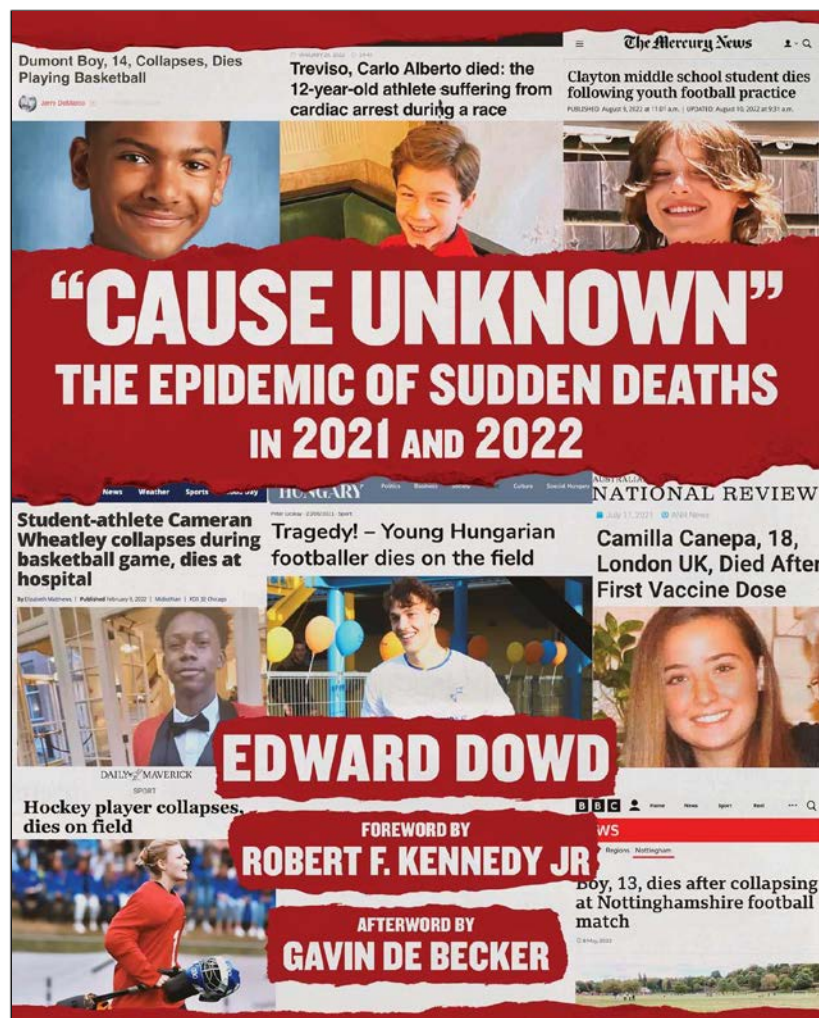

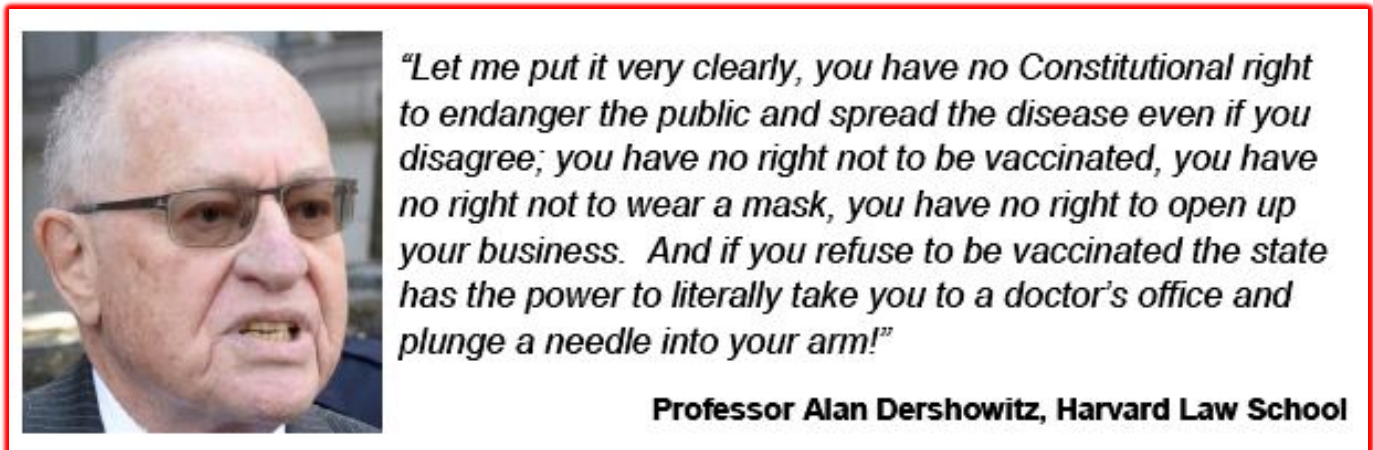

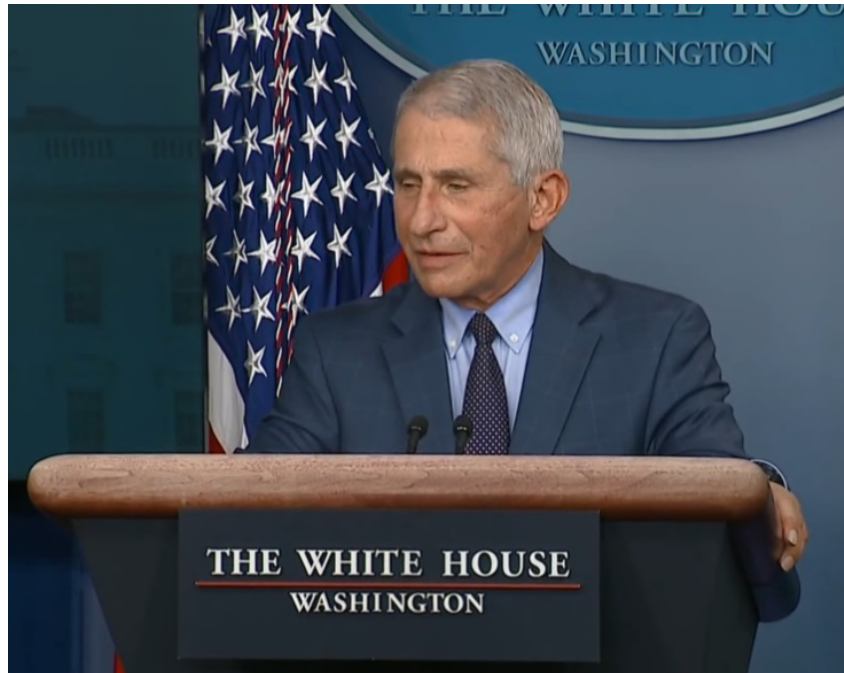
*“Because these viruses generally do not elicit complete and durable protective immunity by themselves, they have not to date been effectively controlled by licensed or experimental vaccines.”*

There were ten cases of severe disease, one in the vaccine, nine in the placebo. For the Moderna trial, it was 94.5% efficacious. Eleven severe events, zero in the vaccine, eleven in the placebo.*

*For those of you not acquainted with the field of vaccinology, that is extraordinary. That is almost to the level of what we see with measles, which is 98% effective. So that’s what we’re dealing with.*

*I used the word ‘efficacious.’ The means what happens in a clinical trial. The word ‘effective’ means, is what the ultimate impact of that vaccine is gonna have on society. **And the only way you can get an effective program is when the people take the vaccine.**”*



## Adolescent Backpedaling by “Doctor Science” and COVID Colleagues Con’t

Re-read that closing paragraph by Doctor Science. He spoon-feeds the Pfizer marketing staff (White House press corps) about the statistical terms efficacious versus effective. He mumbled :

**“And the only way you can get an effective program is when the people take the vaccine.”**

Trite, but only in appearance. We are dealing with Anthony Fauci; a person that Cornell University Professor of Chemistry, Dr. David Collum, described in a widely publicized interview of 3 August 2021 :

### “He’s a pathological liar!”

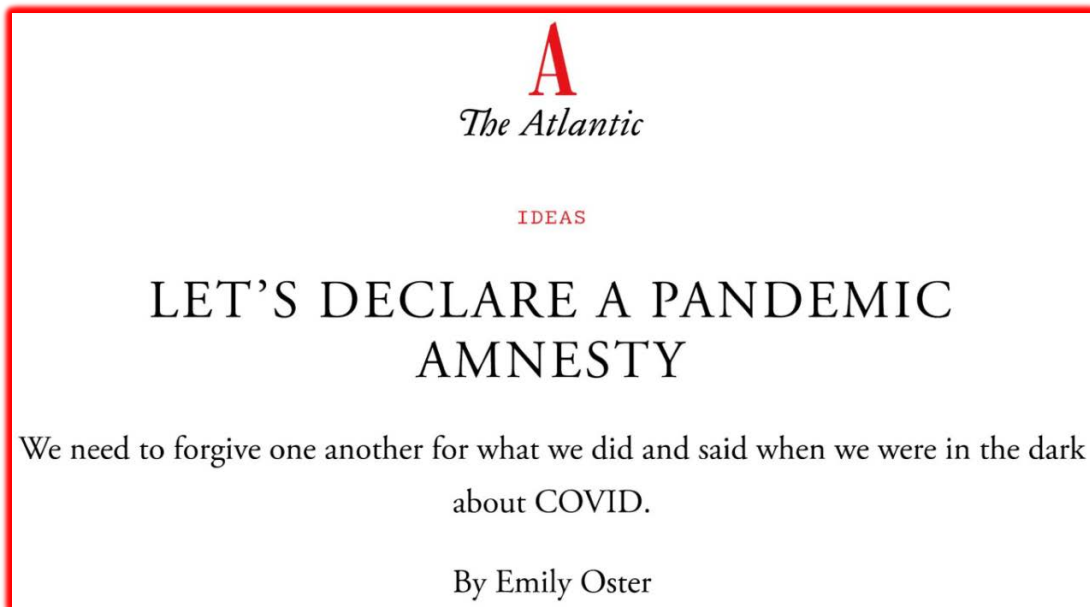

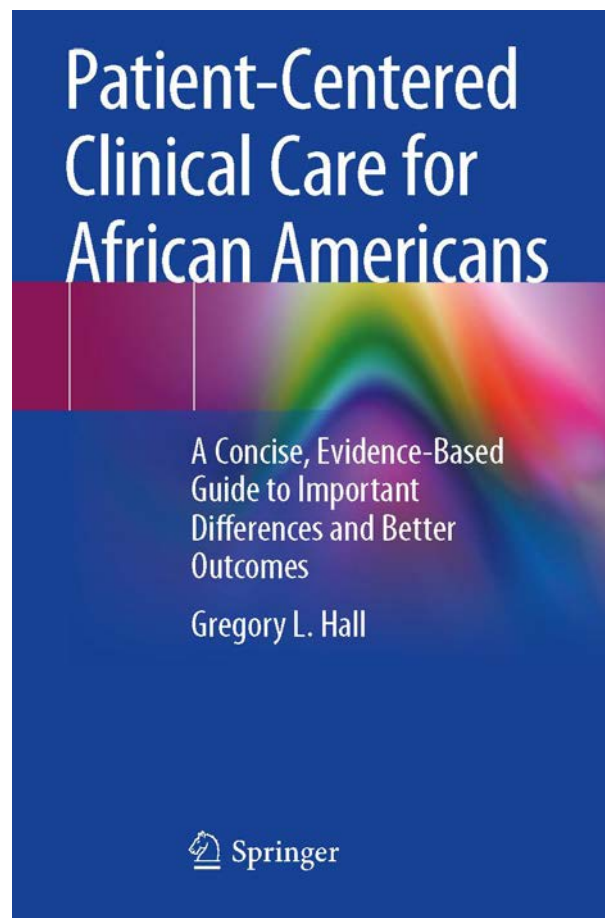
**Conclusion**

Are you saying, in this instance *a priori*, that Dr. Ladapo was **“target(ing) people of color and Black Americans specifically”**?

Your letter, addressed to the perjurious skanks pictured on Page 1, was not one of true admonishment. Dear Messrs. Dorsey and Zuckerberg:

As Attorneys General committed to protecting the safety and well-being of the residents of our states, we write to express our concern about the use of your platforms to spread fraudulent information about coronavirus vaccines and to seek your cooperation in curtailing the dissemination of such information. The people and groups spreading falsehoods and misleading Americans about the safety of coronavirus vaccines are threatening the health of our communities, slowing progress in getting our residents protected from the virus, and undermining economic recovery in our states.

As safe and effective vaccines become available, the end of this pandemic is in sight. This end, however, depends on the widespread acceptance of these vaccines as safe and effective. Unfortunately, misinformation disseminated via your platforms has increased vaccine hesitancy, which will slow economic recovery and, more importantly, ultimately cause even more unnecessary deaths. A small group of individuals use your platforms to downplay the dangers of COVID-19 and spread misinformation about the safety of vaccines. These individuals lack medical expertise and are often motivated by financial interests. According to a recent report by the Center for Countering Digital Hate<sup>1</sup>, so-called “anti-vaxxer” accounts on Facebook, YouTube, Instagram, and Twitter reach more than 59 million followers. “Anti-vaxxers” are using social media platforms to target people of color and Black Americans specifically, members of communities who have suffered the worst health impacts of the virus and whose vaccination rates are lagging.

Given “anti-vaxxers” reliance on your platforms, you are uniquely positioned to prevent the spread of misinformation about coronavirus vaccines that poses a direct threat to the health and safety of millions of Americans in our states and that will prolong our road to recovery.

The updated community guidelines you have established to prevent the spread of vaccine misinformation appear to be a step in the right direction. However, it is apparent that Facebook has not taken sufficient action to identify violations and enforce these guidelines by removing and labelling misinformation and banning repeat offenders. As a result, anti-vaccine misinformation continues to spread on your platforms, in violation of your community standards.

- Twitter and Facebook have yet to remove from all their platforms the accounts of prominent “anti-vaxxers” who have repeatedly violated the companies’ terms of service. Digital media research groups estimate that as of March 10, 12 “anti-vaxxers” personal accounts and their associated organizations, groups and websites are responsible for 65% of public anti-vaccine content on Facebook, Instagram, and Twitter.
- Facebook has failed to consistently apply misinformation labels and popups on Facebook pages and groups that discuss vaccines or COVID-19. For example, the company neglected to apply warning labels on dozens of Facebook groups that “anti-vaxxer” Larry Cook created for his followers. At the same time, the company has mistakenly flagged pro-vaccine pages and content in ways that have undermined pro-vaccine public education efforts.
- Facebook has allowed anti-vaxxers to skirt its policy of removing misinformation that health experts have debunked, by failing to prevent them from using video and streaming tools like Facebook Live and sites like Bitchute, Rumble, and Brighteon to evade detection.

We call on you to take immediate steps to fully enforce your companies’ guidelines against vaccine misinformation. By effectively rooting out fraudulent information about coronavirus vaccines, you can prevent needless illness and death and hasten our road to recovery.

# LET'S DECLARE A PANDEMIC AMNESTY

We need to forgive one another for what we did and said when we were in the dark about COVID.

In April 2020, with nothing else to do, my family took an enormous number of hikes. We all wore cloth masks that I had made myself. We had a family hand signal, which the person in the front would use if someone was approaching on the trail and we needed to put on our masks. Once, when another child got too close to my then-4-year-old son on a bridge, he yelled at her “SOCIAL DISTANCING!”

These precautions were totally misguided. In April 2020, no one got the coronavirus from passing someone else hiking. Outdoor transmission was vanishingly rare. Our cloth masks made out of old bandanas wouldn't have done anything, anyway. But the thing is: *We didn't know.*

I have been reflecting on this lack of knowledge thanks to a class I'm co-teaching at Brown University on COVID. We've spent several lectures reliving the first year of the pandemic, discussing the many important choices we had to make under conditions of tremendous uncertainty.

Some of these choices turned out better than others. To take an example close to my own work, there is an emerging (if not universal) consensus that schools in the U.S. were closed for too long: The health risks of in-school spread were relatively low, whereas the costs to students' well-being and educational progress were high. The latest figures on learning loss are alarming. But in spring and summer 2020, we had only glimmers of information. Reasonable people—people who cared about children and teachers—advocated on both sides of the reopening debate.

Another example: When the vaccines came out, we lacked definitive data on the relative efficacies of the Johnson & Johnson shot versus the mRNA options from Pfizer and Moderna. The mRNA vaccines have won out. But at the time, many people in public health were either neutral or expressed a J&J preference. This misstep wasn't nefarious. It was the result of uncertainty.

---

Obviously *some* people intended to mislead and made wildly irresponsible claims. Remember when the public-health community had to spend a lot of time and resources urging Americans not to inject themselves with bleach? That was bad. Misinformation was, and remains, a huge problem. But most errors were made by people who were working in earnest for the good of society.

Given the amount of uncertainty, almost every position was taken on every topic. And on every topic, someone was eventually proved right, and someone else was proved wrong. In some instances, the right people were right for the wrong reasons. In other instances, they had a prescient understanding of the available information.

The people who got it right, for whatever reason, may want to gloat. Those who got it wrong, for whatever reason, may feel defensive and retrench into a position that doesn't accord with the facts. All of this gloating and defensiveness continues to gobble up a lot of social energy and to drive the culture wars, especially on the internet. These discussions are heated, unpleasant and, ultimately, unproductive. In the face of so much uncertainty, getting something right had a hefty element of luck. And, similarly, getting something wrong wasn't a moral failing. Treating pandemic choices as a scorecard on which some people racked up more points than others is preventing us from moving forward.

We have to put these fights aside and declare a pandemic amnesty. We can leave out the willful purveyors of actual misinformation while forgiving the hard calls that people had no choice but to make with imperfect knowledge. Los Angeles County closed its beaches in summer 2020. Ex post facto, this makes no more sense than my family's masked hiking trips. But we need to learn from our mistakes and then let them go. We need to forgive the attacks, too. Because I thought schools should reopen and argued that kids as a group were not at high risk, I was called a "teacher killer" and a "*génocidaire*." It wasn't pleasant, but feelings were high. And I certainly don't need to dissect and rehash that time for the rest of my days.

Moving on is crucial now, because the pandemic created many problems that we still need to solve.

Student test scores have shown historic declines, more so in math than in reading, and more so for students who were disadvantaged at the start. We need to collect data, experiment, and invest. Is high-dosage tutoring more or less cost-effective than extended school years? Why have some states recovered faster than others? We should focus on questions like these, because answering them is how we will help our children recover.


Many people have neglected their health care over the past several years. Notably, routine vaccination rates for children (for measles, pertussis, etc.) are way down. Rather than debating the role that messaging about COVID vaccines had in this decline, we need to put all our energy into bringing these rates back up. Pediatricians and public-health officials will need to work together on community outreach, and politicians will need to consider school mandates.

---

The standard saying is that those who forget history are doomed to repeat it. But dwelling on the mistakes of history can lead to a repetitive doom loop as well. Let's acknowledge that we made complicated choices in the face of deep uncertainty, and then try to work together to build back and move forward.

Dear Dr. Paxson,

I am a Representative who champions informed consent for Rhode Island residents. My concerns, expressed below, are shared by four Rhode Island physicians who have endorsed this letter.

As the president of an educational institution that holds both a medical school and extensive research facilities, I am sure that you will agree with me that when our citizens make healthcare decisions, we are obligated to give them as much pertinent information as possible. Providing each person with thorough and complete data allows them to make informed decisions. They are, after all, the ultimate recipients of the consequences. To my knowledge, that policy of medical transparency is an expectation and imperative in our healthcare system.

Each night as I watch television, I view commercials for drugs and treatments that are accompanied by a list of possible adverse reactions, because patients deserve to have all the facts as they make their decisions. Medical mandates that are not accompanied by complete transparency based on the most up-to-date data and facts are an anathema to responsible medical practice and leadership.

It is my understanding that Brown University under your direction has mandated coronavirus vaccination for every student. Exemptions are rarely given. It has also come to my attention that you are not providing students with a complete understanding of the benefits, risks, and possible complications of vaccination. I would like to understand the reasoning behind your rejection of standard practices of medical transparency for Brown University students.

As an example, the following matter of concern was brought to my attention by a colleague, Rhode Island academic physician-epidemiologist, Andrew G. Bostom, MD, MS, whose [distinguished career](#) included his residency training, and faculty [clinical research](#), practice, and teaching, at the Brown University Medical School, over the past 30-years.

Dr. Bostom obtained and recorded (transcript [here](#); audio [here](#)) the testimony of a respected Rhode Island Cardiologist who was on call when a 20-year-old, male Brown University student,

in March, 2021, was admitted to The Miriam Hospital for a covid-19 mRNA vaccine-induced “myopericarditis” (i.e., a serious inflammation of the heart muscle, and its suspending sack).

The Cardiologist informant’s narrative was independently corroborated by Dr. Bostom using three separate, de-identified (and [HIPPA compliant](#)) public sources:

- A Vaccine Adverse Event Reporting System (VAERS) [case report](#) (elaborated [here](#))
- The Rhode Island Department of Health 2021 [hospitalization database](#) (elaborated [here](#))
- A 9/9/21 [publication](#) by Y. Patel, et al, of The Brown University Cardiology Division (discussed [here](#))

I share Dr. Bostom’s concern that during the 17-months which have elapsed since this serious vaccine injury, Brown University has never acknowledged it occurred, which could have readily been done while protecting the anonymity of the student victim. Moreover, the University has not shared that information (again, anonymously) with its own [most at risk](#), healthy young male 18 to 24 year old student population. Such concealment violates the ethics of risk/benefit-based informed consent, which applies to all vaccinations, including those that are [deemed mandatory](#).


It is not beyond possibility that the Brown University student population has also experienced specific covid-19 lung disease (“pneumonia,” or “lower respiratory tract infection”) resulting in undisclosed hospitalizations. If any students have experienced such serious infection, their adverse outcomes, too, should be enumerated, and presented to your students as part of an appropriate risk/benefit-based informed consent process.

Brown University’s current informed consent process for COVID-19 vaccination simply refers students to templates like [this one](#) from RIDOH. None of the following established adverse reactions **conferred** by covid vaccines are mentioned: [anaphylaxis](#), [myocarditis/pericarditis](#); [thrombosis with thrombocytopenia](#); [Bell’s Palsy](#), [Guillain-Barré syndrome](#), cardiac dysrhythmia (esp. [atrial fibrillation](#)), and [rashes](#). Omission of myocarditis is particularly troubling because this illness has serious and debilitating complications, and your university has experienced the specific case of a Brown student post-covid vaccine myopericarditis that Dr. Bostom has uncovered.

My concern for complete transparency so students may make informed decisions as relates to their healthcare choices is shared by the doctors cosigning this letter. Together, we call upon Brown to belatedly acknowledge its student case of covid vaccine-induced myopericarditis from March, 2021, and set the example of true risk/benefit-based informed consent for Rhode Island, going forward.

Given both the [proliferation](#) of natural immunity, and [evolution](#) of SARS-CoV-2 into an overwhelmingly [upper respiratory tract](#) infection, whose serious morbidity risk to healthy students is below even the [minimal risk](#) posed by ancestral strains, we, the undersigned, also urge Brown University to withdraw the vaccine mandate altogether. Finally, we, the undersigned, note that both [The University of Rhode Island](#), and [Providence College](#) here in Rhode Island previously dropped their covid-19 vaccine mandates.



## **ORDER DIRECTING IMPANELMENT OF A STATEWIDE GRAND JURY**

THE COURT has received a Petition from the Honorable Ron DeSantis, Governor of Florida, for an order to impanel a statewide grand jury. “[T]his Court’s responsibility in impaneling a statewide grand jury is ‘ministerial in nature’” and is limited to reviewing whether the petition meets the statutory requirements. *State ex rel. Reichle v. Edwards*, 409 So. 2d 1043, 1044 (Fla. 1982) (quoting *In re Advisory Opinion to the Governor*, 290 So. 2d 473, 474 (Fla. 1974)). Being fully advised of the relevant matters, the Court hereby finds as follows:

A. The Petitioner, the Honorable Ron DeSantis, Governor of Florida, has alleged that good and sufficient reason exists and that it is in the public interest to impanel a statewide grand jury, with jurisdiction throughout the State of Florida, to investigate crime, return indictments, make presentments, and otherwise perform all functions of a grand jury with regard to the offenses listed in section 905.34, Florida Statutes (2022).

B. The matters to be inquired into are any offense listed in section 905.34 that:

(1) relates to the following:

(a) Individuals, persons, and entities, including, but not limited to, pharmaceutical manufacturers (and their executive officers) and other medical associations or organizations involved in the design, development, clinical testing or investigation, manufacture, marketing, representation, advertising, promotion, labeling, distribution, formulation, packing, sale, purchase, donation, dispensing, prescribing, administration, or use of vaccines purported to prevent COVID-19 infection, symptoms, and transmission;

(b) other criminal activity or wrongdoing that the statewide grand jury uncovers during the course of the investigation if it determines that pursuing the criminal activity or wrongdoing is in the best interests of the investigation;

and

(2) is occurring, or has occurred, in two or more judicial circuits as part of a related transaction or is connected with an organized criminal conspiracy affecting two or more judicial circuits, as required by section 905.34, Florida Statutes.

WHEREFORE, THE COURT, pursuant to the provisions of sections 905.31 through 905.40, Florida Statutes, Statewide Grand Jury Act, hereby orders as follows:

1. A statewide grand jury shall be promptly impaneled for a term of twelve calendar months, to run from the date of impanelment, with jurisdiction throughout the State of Florida, to investigate crime, return indictments, make presentments, and otherwise perform all functions of a grand jury with regard to the offenses stated herein.

2. The statewide grand jury shall be drawn from the certified jury lists submitted by the chief judges of the Fifth, Sixth, Tenth, Twelfth, and Thirteenth Judicial Circuits.

3. The Honorable Ronald Ficarrotta, Chief Judge in and for the Thirteenth Judicial Circuit, is designated as presiding judge over the statewide grand jury. In his capacity as the presiding judge, the Honorable Ronald Ficarrotta shall maintain judicial supervision of the statewide grand jury, and all indictments, presentments, and formal returns of any kind made by such grand jury shall be returned to the presiding judge. The presiding judge may designate an alternate presiding judge in the event of calendar conflicts or otherwise and to assist in the administrative process of the statewide grand jury.

4. John A. Tomasino, Clerk of the Supreme Court of Florida, is hereby designated clerk of this statewide grand jury and is empowered to deputize any clerk of a circuit court or any deputy clerk of a circuit court to issue necessary process and to carry out the administrative functions of the statewide grand jury.



Petitioner, Ron DeSantis, Governor of the State of Florida, respectfully petitions this Court under section 905.33, Florida Statutes (2022), for an order to impanel a statewide grand jury. As grounds for the petition, Petitioner offers the following:

Jurisdiction

1. Petitioner, Ron DeSantis, is the Governor of the State of Florida.
2. This Court has jurisdiction over this matter under section 905.33(1), which provides:

Whenever the Governor, for good and sufficient reason, deems it to be in the public interest to impanel a statewide grand jury, she or he may petition in writing to the Supreme Court for an order impaneling a statewide grand jury. . . . The Supreme Court may order the impaneling of a statewide grand jury, in accordance with the petition, for a term of 12 calendar months.

3. Petitioner has consulted with the Attorney General and the statewide prosecutor regarding this petition. The statewide

prosecutor will serve as the legal adviser to the statewide grand jury. See § 905.36, Fla. Stat.

4. For the good and sufficient reasons described below, Petitioner has determined that it is in the public interest to impanel a statewide grand jury and that the crimes and wrongs to be investigated, as also set forth below, are of a multicircuit nature. See § 905.33(1), Fla. Stat.

#### Factual Background

5. The federal government, medical associations, and other experts have created an expectation that receiving a COVID-19 vaccine is an ethical or civic duty and that choosing not to get vaccinated against COVID-19 is selfish and harmful to others.<sup>1</sup> As one politician in another state put it, if a person chooses not to receive a vaccine, they

might “go home and kiss [their] grandmother and wind-up killing [their] grandmother.”<sup>2</sup>

6. While Florida rejected vaccine mandates and passports, some Floridians made the choice to receive the COVID-19 vaccine because they believed that receiving the vaccine would prevent them from spreading COVID-19 to others.

7. The widespread belief that the COVID-19 vaccines prevented the disease from spreading became so pervasive that the President of the United States himself believed it to be true. He sought to impose a variety of vaccine mandates on the American people, including healthcare workers and members of the military, which were premised on the notion that “unvaccinated people spread the virus” and “the best way to slow the spread of COVID-19 and to prevent infection by the Delta variant or other variants is to be vaccinated.”<sup>3</sup>

He even stated that “[y]ou’re not going to get Covid if you have these vaccinations.”<sup>4</sup>

8. Florida’s prohibitions on vaccine requirements could not prevent all federal vaccine requirements, such as those for military members. Many Floridians serving in Florida and abroad were forced to submit to COVID-19 vaccination as a condition of employment. These mandates were imposed even as evidence surfaced of increased cases of myocarditis and pericarditis in those vaccinated.<sup>5</sup>

9. Various state and federal health authorities, including the Centers for Disease Control and Prevention (CDC), held the belief that the vaccines prevented transmission, and in turn issued guidance recommending the vaccines as effective at “limiting the spread of the virus that causes it.”<sup>6</sup> The CDC’s website stated the vaccines were “safe and effective as determined by data from the manufacturers,” but that statement was later removed.<sup>7</sup> The CDC also advised that

“COVID-19 vaccination can reduce the spread of disease overall, helping protect people around you.”<sup>8</sup> Dr. Anthony Fauci, Director of the National Institute of Allergy and Infectious Diseases, unequivocally asserted that the vaccines prevented transmission.<sup>9</sup> And the White House issued a press briefing just last year, only days before Christmas, threatening “the unvaccinated” with “a winter of severe illness and death.”<sup>10</sup>

10. It is impossible to imagine that so many influential individuals came to this view on their own. Rather, it is likely that individuals and companies with an incentive to do so created these perceptions for financial gain.

11. For example, on November 30, 2020, the Chief Executive Officer of Moderna told the public that a study “confirms the ability of our vaccine to prevent COVID-19 disease with 94.1% efficacy.”<sup>11</sup>

12. Pfizer similarly stated that its vaccine was “highly effective with 91.3% vaccine efficacy observed against COVID-19 . . . through up to six months after the second dose.”<sup>12</sup> Pfizer’s CEO, Albert Bourla, stated that its “COVID-19 vaccine was 100% effective” in preventing cases in South Africa.<sup>13</sup>

13. Moderna promoted an article on its Twitter page titled “10 Common Vaccine Myths Busted,” which stated that “[g]etting vaccinated is like wearing a mask—it isn’t just about protecting you, but also your community” and “[t]he more people who are vaccinated, the fewer chances a disease has to spread.”<sup>14</sup>

14. Both Pfizer and Moderna use their websites to promote the theory that their COVID-19 vaccines help develop “herd immunity.” According to Moderna, herd immunity is the “indirect group protection from an infectious disease that happens when a population is immune through either vaccination or previous infection.”<sup>15</sup> Moderna’s website states that “[t]o safely achieve herd immunity against COVID-19, a large amount of a population needs to be vaccinated” and that this “help[s] protect those who cannot get vaccinated.”<sup>16</sup> Moderna recommends COVID-19 vaccination “even if you are healthy” because a vaccine may “[a]dd to the number of people in the community who are protected from getting COVID-19, contributing to herd immunity.”<sup>17</sup>

15. Pfizer’s website asserts that “[w]hen enough people are vaccinated, everyone—including those who are too young or too sick to be immunized—receives some protection from the spread of

diseases.”<sup>18</sup> Pfizer’s Twitter page states that “[t]he ability to vaccinate at speed to gain herd immunity and stop transmission is our highest priority” and that “[v]accination remains the best tool we have to help protect lives and achieve herd immunity.”<sup>19</sup>

16. Some representations by the pharmaceutical manufacturers even suggested that the vaccines would help end the pandemic.<sup>20</sup>

17. In January 2021, Moderna CEO Stephane Bancel stated, “[t]he antibody decay generated by the vaccine in humans goes down very slowly” and “[w]e believe there will be protection potentially for a couple of years.”<sup>21</sup> Yet not even a year later, Bancel announced that

clinical studies indicating an increased risk of breakthrough infections “illustrates the impact of waning immunity and supports the need for a booster to maintain high levels of protection.”<sup>22</sup>

18. Only months ago, a Pfizer executive confirmed at a hearing in front of the European Parliament that the company did not test its COVID-19 vaccines before they entered the market to determine whether they prevented the transmission of COVID-19.<sup>23</sup>

19. On December 29, 2020, the World Health Organization’s chief scientist, Dr. Soumya Swaminathan, stated that there was a lack of evidence “to be confident that it’s going to prevent people from actually getting the infection and therefore being able to pass it on.”<sup>24</sup>

Nearly a year later, World Health Organization officials admitted that the vaccines did “not fully prevent transmission.”<sup>25</sup> Indeed, various studies have seriously undermined the narrative that vaccination prevents the transmission of COVID-19, especially the delta and omicron variants.<sup>26</sup> This calls into question the accuracy of pharmaceutical manufacturers’ representations that their vaccines would stop transmission, develop herd immunity, and help end the pandemic.

20. For children ages 5 through 17, Moderna states that the known risks and possible severe complications of COVID-19

outweigh the potential risks of “having a rare, adverse reaction to vaccination.”<sup>27</sup> Bourla tweeted that severe COVID-19 was “rare in children” while urging that “widespread vaccination is a critical tool to stop transmission.”<sup>28</sup> But just three months later, Bourla said the Delta variant posed a “substantial threat” to children.<sup>29</sup>

21. On the contrary, the Florida Department of Health recognized reduced COVID-19 vaccine efficacy in children and a limited risk of severe illness from COVID-19 in healthy children.<sup>30</sup> The Florida Department of Health issued guidance recommending that healthy children may not benefit from the COVID-19 vaccine and recognizing that the risk of myocarditis, particularly for adolescents 16 to 17 years of age, may outweigh the benefit of COVID-19 vaccination.<sup>31</sup>

22. In April 2021, increased cases of myocarditis and pericarditis were reported in individuals in the United States after receiving the

Pfizer and Moderna COVID-19 vaccinations.<sup>32</sup> In June 2021, Moderna shared a press release via Twitter (which was later removed) and stated, “we have not established a causal association with [myocarditis and/or pericarditis and] our vaccine.”<sup>33</sup> Around the same time, a spokeswoman for Pfizer said that “a causal link to the vaccine has not been established” and that “with a vast number of people vaccinated to date, the benefit risk profile of our vaccine remains positive.”<sup>34</sup> But just four months later, both companies acknowledged the occurrence of myocarditis on their websites, representing that it is an “extremely” or “very” rare side effect.<sup>35</sup>

Moderna stated that myocarditis and pericarditis are “typically mild cases and individuals tend to recover within a short time.”<sup>36</sup>

23. The Florida Department of Health conducted its own analysis through a self-controlled case series to study mortality risk following mRNA COVID-19 vaccination and found an increase in the relative incidence of cardiac-related deaths among males 18-39 years old within 28 days following mRNA vaccination.<sup>37</sup>

24. Reports from other countries also indicate that there is a connection between COVID-19 vaccines and cardiovascular events, even death. French and Canadian studies recognize an increase in rates of myocarditis or pericarditis following receipt of COVID-19 mRNA vaccines.<sup>38</sup> A recent Swiss report recognized that only serious

cases of myocarditis requiring hospitalization are generally reported, suggesting the true incidence of myocardial damage would therefore “likely be much higher” in the general population.<sup>39</sup> A German study of autopsies performed on people who died unexpectedly at home within 20 days of receiving an mRNA COVID-19 vaccine indicated that myocarditis “can be a potentially lethal complication” following mRNA vaccination.<sup>40</sup> Furthermore, excess mortality from heart attacks rose significantly during the COVID-19 pandemic, especially among individuals ages 25 to 44.<sup>41</sup> These reports raise questions regarding whether the representations made by the pharmaceutical

industry with respect to the safety and risks of their COVID-19 vaccines have been true.

25. Florida law prohibits fraudulent practices, including the dissemination of false or misleading advertisements of a drug and the use of any representation or suggestion in any advertisement relating to a drug that an application of a drug is effective when it is not. § 499.0051(11), Fla. Stat. The pharmaceutical industry has a notorious history of misleading the public for financial gain.<sup>42</sup> Questions have been raised regarding the veracity of the representations made by the pharmaceutical manufacturers of COVID-19 vaccines, particularly with respect to transmission,

prevention, efficacy, and safety. An investigation is warranted to determine whether the pharmaceutical industry has engaged in fraudulent practices. The people of Florida deserve to know the truth.

### Nature and Scope of the Investigation

26. In light of the foregoing information, Petitioner has determined that there are good and sufficient reasons to deem it to be in the public interest to impanel a statewide grand jury to investigate criminal or wrongful activity in Florida relating to the development, promotion, and distribution of vaccines purported to prevent COVID-19 infection, symptoms, and transmission.

27. Specifically, such investigation should consider any crime or wrong listed or described in section 905.34 that relates to the following:

(a) Individuals, persons, and entities, including, but not limited to, pharmaceutical manufacturers (and their executive officers) and other medical associations or organizations involved in the design, development, clinical testing or investigation, manufacture, marketing, representation, advertising, promotion, labeling, distribution, formulation, packing, sale, purchase,

donation, dispensing, prescribing, administration, or use of vaccines purported to prevent COVID-19 infection, symptoms, and transmission;

(b) other criminal activity or wrongdoing that the statewide grand jury uncovers during the course of the investigation if it determines that pursuing the criminal activity or wrongdoing is in the best interests of the investigation.

28. A statewide grand jury is an appropriate vehicle to examine these matters, identify any deficiencies in current laws and enforcement methods, and recommend revised or additional laws and enforcement methods.

29. Pursuant to sections 905.33 and 905.34, the jurisdiction of the statewide grand jury will extend throughout the state to investigate crimes, return indictments, make presentments or direct issuance of reports, and otherwise perform all functions of a statewide grand jury with regard to any offense enumerated in section 905.34, including but not limited to:

(a) Any crime involving, or resulting in, fraud or deceit upon any person [e.g., Chapter 817 (false pretenses and frauds, generally)];

(b) Chapter 499 (crimes under Part I of the Florida Drug and Cosmetic Act);

(c) Chapter 895 (violations of the provisions of the Florida Racketeer Influenced and Corrupt Organization Act (RICO), including offenses listed under section 895.02); and

(d) Any attempt, solicitation, or conspiracy to commit any violation of the crimes specifically enumerated above.

30. The Florida Department of Law Enforcement will serve as the primary investigator, though the statewide grand jury may seek the assistance of any law enforcement entity or agency in Florida.

31. The investigation is not limited to any region of the state. Petitioner requests, however, that in the interest of convenience of prospective grand jury witnesses, law enforcement officers, and others, a region of the state should be designated as the base operating area. *See* § 905.37(2).

32. Prospective jurors should be drawn from that region.

33. Petitioner respectfully requests that this Court designate the Fifth, Sixth, Tenth, Twelfth, and Thirteenth Judicial Circuits as the base operating area in which the statewide grand jury should be


impaneled because of the region's central location within the state and its accessibility and convenience for grand jury participants.

34. Petitioner requests that the Chief Justice designate a circuit judge in one of the aforementioned judicial circuits to preside over the statewide grand jury. *See* § 905.33(2), Fla. Stat.


35. The statewide grand jury should be impaneled for a term of 12 calendar months, subject to an extension of up to six additional months as provided by law. *See* § 905.33(1), Fla. Stat.

For the foregoing reasons, Petitioner respectfully requests that this Court order that a statewide grand jury be impaneled.



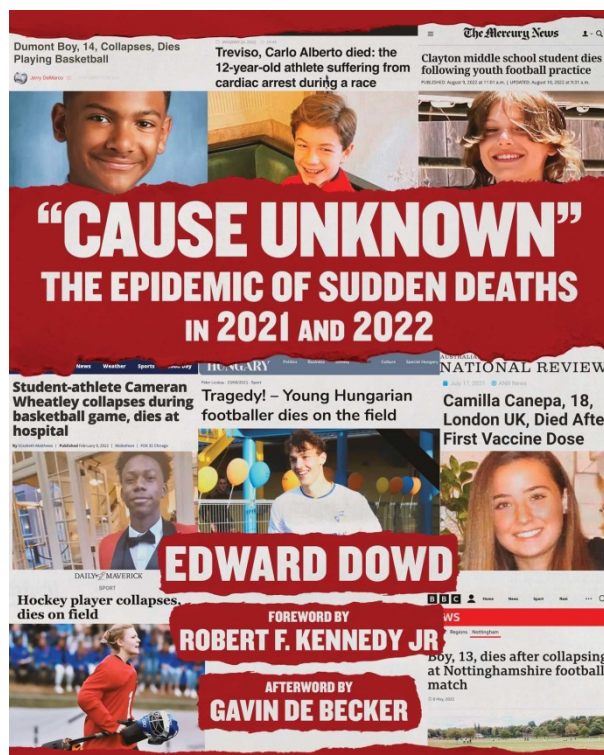

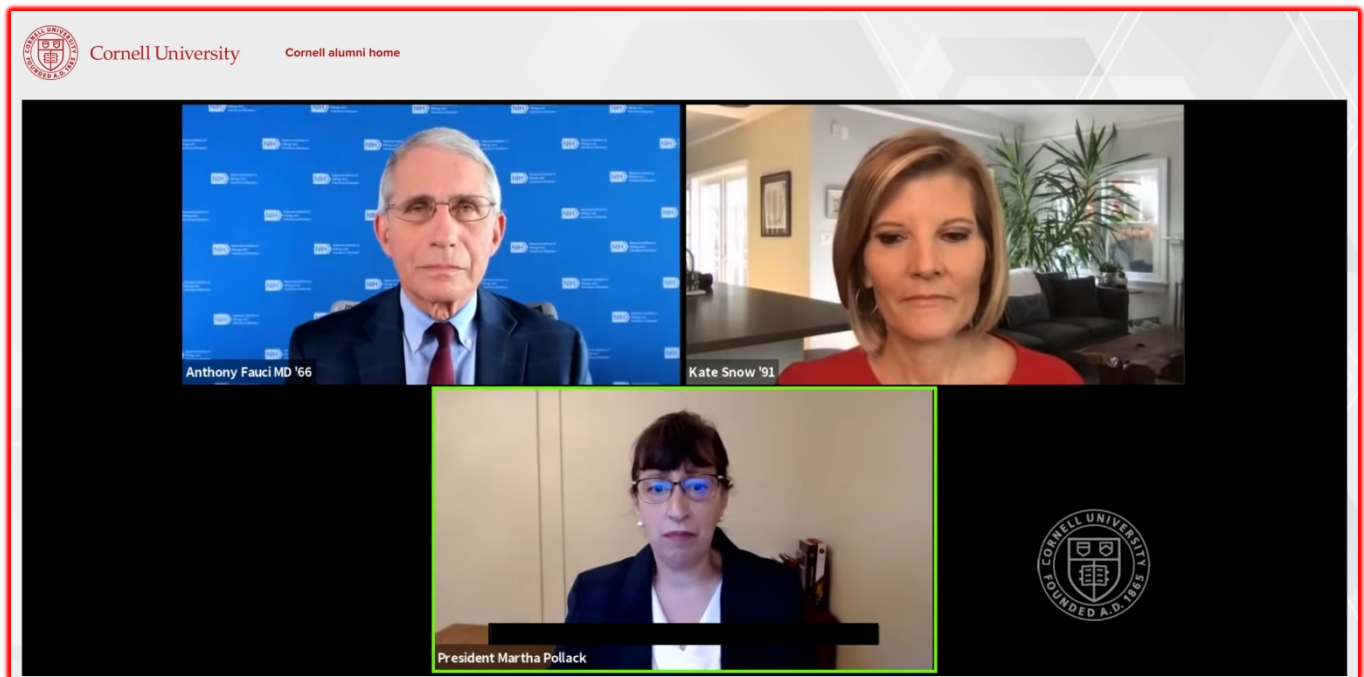

This Subject is presented to you *with permission*. I have had many conversations with Mr. Philip Nache and Mrs. Jummai Nache wherein they jointly encouraged this formal written proposal.

**Other Similar Incident (OSI) Evidence Admission Criteria (State of Florida)**

Guidance on this topic is somewhat sparse in the State of Florida. Despite being an out-of-state resident, the guidance I have gleaned strongly appears to support admission, to the Grand Jury, of the facts surrounding the destruction of the physical well-being of Mrs. Jummai Nache, which occurred as a direct result of the two-fold mRNA injections, coerced upon her by her former employer, the University of Minnesota.

Regarding the Petition filed by Governor DeSantis and General Council Newman on 13 December 2022, the Nache case facts comport with and reinforce all Petition theory; indeed with each and every paragraph, especially wherein such speaks to the CDC/FDA/Pfizer misinformation and disinformation that criminally/purposely obviated **complete and true informed consent**.

**It took six months of haggling to get the University of Minnesota to release the medical report on Jummai; now over 1300 pages.** As a window on their early knowledge of mRNA induced injuries, caused by University employment “vaccination” mandates, we sample Page 183 of that report (screenshot):

**Assessment:**

Jummai P Nache is a 50 year old female patient who is following up after a prolonged admission and continued rehab after MIS-A. Her clinical course has left her with life-changing physical disfigurement which is almost certainly going to need amputation.

Most of our visit was spent again discussing the potential role of the vaccine in this process. Dr. Fontana shared the letter from the CDC stating that this was MIS-A without clear involvement from the vaccine, though it can't (and likely never will be) excluded as contributing to some extent. Since the last visit, and separate from the laboratory evidence discussed with the CDC, I did have the PF4 antibody testing done on a blood sample saved from around the same day as her arterial thrombotic events. This testing was negative. Thrombotic Thrombocytopenic Syndrome (TTS, previously termed VITT as mentioned in my previous note) is the syndrome linked to the infrequent CSVT and other thrombotic events linked to Johnson and Johnson vaccines. While we do not have pathognomonic tests for this (or most other disorders), the PF-4 antibody testing is quite sensitive, so the absence of it is reassuring against that diagnosis. Greinacher et al. **Thrombotic Thrombocytopenia after ChAdOx1 nCov-19 Vaccination**, *NEJM* April 2021 <https://www.nejm.org/doi/full/10.1056/NEJMoa2104840>). The onset here was also a bit early, based on discussions I had with an expert on the topic at another institution in reviewing this case.

We spent 45 minutes reviewing what constitutes MIS-A versus other similar inflammatory or infectious states, how the vaccine could have hypothetically amplified an MIS-A that might have occurred anyway, but since we do not know why some are susceptible to MIS and not others, we cannot even say that for sure. My feeling is that they are still in the coping phases of this, and more will come with the amputations needed, so I am just trying to support Jummai and Phillip through this with as much evidence-based background to Jummai's events as I can. After myself and seven other governors called on the Trump Administration to release more doses, HHS Secretary Alex Azar said that relief was on the way. To date, however, the federal government has not acted on that promise – in fact, New York will receive just 250,000 doses this week, 50,000 fewer than the week prior.

Because you are not bound by commitments that Moderna made as part of Operation Warp Speed, I am requesting that the State of New York be permitted to directly purchase doses from you. The distribution of any doses obtained directly from Pfizer will follow the rigorous guidance the State has established, while enabling us to fill the dosage gap created this week by the outgoing federal administration. All of this will further our goal to vaccinate 70 to 90 percent of New Yorkers as soon as possible and reach herd immunity.

You no doubt understand the challenges New York and other states face. Shifting guidance from the Centers for Disease Control and Prevention drove the number of New Yorkers eligible and prioritized for the vaccine from 5 million to 7 million practically overnight. The federal administration essentially opened up a floodgate while cutting our supply – leading to confusion, frustration, and dashed hopes.

Pfizer is a New York company – something I am greatly proud of. The company’s decision to opt out of Operation Warp Speed, which the Biden administration plans to overhaul, puts it in a unique situation that could help us save lives right here in New York. I am happy to discuss this matter further with you.

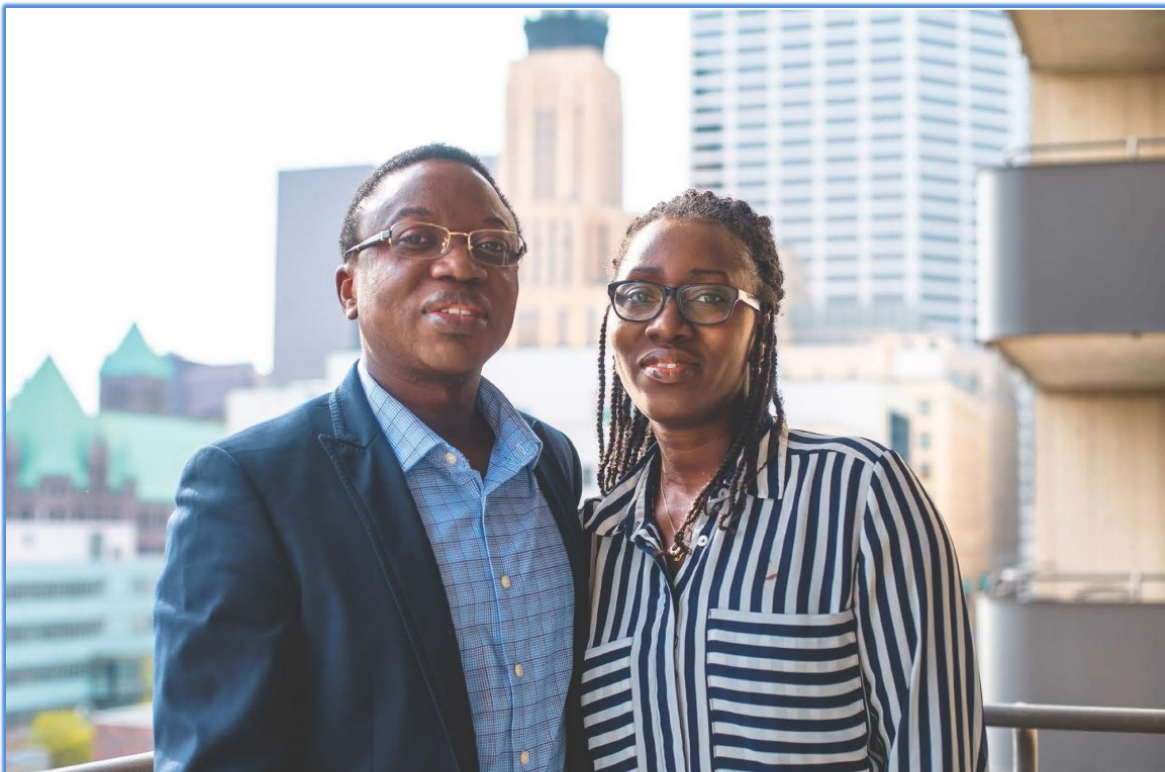

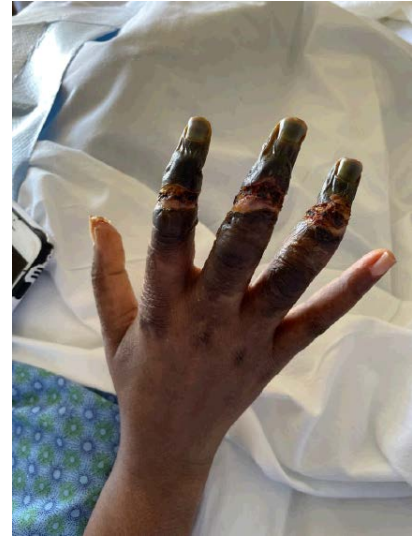
