Dear Chairman Kayser :

You are in hard-copy receipt of Reference 1, which included five hard-copy enclosures. On Page 40 of 45 of the cover letter, I requested that the DEMAND be presented at the January 2024 Cornell University Board of Trustee (BoT) meetings. According to the Cornell BoT web page, the relevant subcommittees are scheduled as follows :

I will forward by-email this letter, as well as Reference 1 and Reference 2 to the BoT chairs listed above.

Significant updates to Reference 1 are offered below.

Update #1 to Reference 1

Congressman Dr. Brad Wenstrup was a recipient of Reference 1. Shortly thereafter, I was contacted by congressional staff regarding the upcoming testimony of **Cornell University graduate Dr. Anthony Fauci**. Agreement to that end involved over a year of haggling with his many personal and taxpayer sponsored attorneys. The Wenstrup letter confirming the Fauci testimony dates of 8/9 January 2024 is Attachment 1.

As discussed in Reference 1, my 20 November 2021 letter to Attorney Michael van der Veen, counsel to President Donald Trump, stated a key operative of the COVID-19 Crime Syndicate :

“The so-called ‘COVID-19 vaccine’ is not in response to the SARS-CoV-2 virus; **but the exact opposite!** Attempts to patent mRNA contraptions, and market such as a ‘vaccine’ for SARS-CoV-1 had failed. SARS-CoV-2 was intentionally released to overcome (“blow up!”) traditional systemic approaches to vaccine formulation, development, and safety confirmation protocols. A conspiracy theory? Hardly. Defendants and associated witnesses have already boasted of this reality, in public! ”

My **“exact opposite”** assertion, which I verbalized in mid-2020, has been the focus of diatribe. However, during a break on 8 January 2024, Congresswoman Greene stated as follows :

“We’re having him (Dr. Fauci) come in before our full committee later this year.

I think what has taken-me-back is the fact that Dr. Fauci fully believed in creating or enhancing viruses using the Gain of Function (GoF) research or that capability in order to create vaccines.

And this is a shocking thing to think about; the average person or most doctors practicing, you know, every day in their doctor’s offices, are blown away with the fact that he would create or enhance a virus in order to create a vaccine to fight it, because the risk is so high.

*And what is shocking to me is that back in 2012 he actually wrote a paper about it, and wrote about a scenario that a pandemic could get released upon the world, and he spelled that out in his article. And in the article he says that it is worth the risk. **But it’s not worth the risk, because millions of people died. Millions of people lost loved ones.***

And actually this is more of an evil version of science, it is like a Dr. Frankenstein of science, that American taxpayers would never want their tax dollars used for. The clarity that I heard him talk about, that we were asking him about this specific article is that he knew the risks. And that is clear. Not only did he write about it in 2012, but we were talking about it in there.

And I think I can speak for many Americans, when I can say ‘absolutely’ that he belongs in jail for that.”



As of this writing, the mentioned **public** full committee hearing date with Dr. Fauci is pending.

Update #2 to Reference 1

Media coverage of the Dr. Fauci sworn testimony of 8/9 January 2024, at the *Select Subcommittee on the Coronavirus Pandemic*, which is chaired by Congressman Dr. Wenstrup, was typified as follows:



Three days after the Fauci testimony, on 12 January 2024, **practicing** globally recognized medical experts testified before the Congresswoman Marjorie Greene hearing, entitled:

INJURIES CAUSED BY COVID-19 VACCINES – [PART 2](#)

The experts included Dr. Ryan Cole, Dr. Kirk Milhoan and Dr. Peter A. McCullough. In his SubStack of 21 January 2024, Dr. McCullough declared as follows:

“What is reported about Fauci’s testimony suggests he is a guilty man. A witness, subject, or target who is truly culpable for an atrocity will be evasive and do everything to conceal participation in what has occurred. It is likely when all the evidence is fully considered that the following will be recognized:

Fauci likely will be shown to have participated in the design and creation of the gain-of-function chimeric virus SARS-CoV-2 . . .”

Likely?! Evidence that Cornell graduate Dr. Fauci “*participated in the design and creation of the gain-of-function chimeric virus*” **is already overwhelming; there is nothing “likely” about it.**

More importantly, such simplistic cut-the-baby-in-half assertions divert from exposing what motivated the COVID-19 Crime Syndicate. Indeed, said motivational evidence continued to accumulate on the campus of our alma mater **as early as October 2020**; and remains intrinsic to my **“exact opposite”** allegation, as well as the confirmatory consternations of Congresswoman Greene (Page 2 above).

Update #3 to Reference 1

I have received many comments in response to Reference 1. At the appropriate time I will share such. One criticism questioned my assertion that the Cornell University Board of Trustees (BoT) was specifically and actively involved in the maintenance and determined guardianship of the **reputation** of my alma mater. You most certainly are.

A long-standing well-known page on the Cornell BoT website is here (screenshot):

The trustee role

The Board of Trustees is comprised of 64 members, representing students, faculty, employees, alumni, labor, agriculture, and New York State government. Cornell's board is the only Ivy League board that includes trustees elected by students, faculty and employees.

The board is vested with "supreme control" over the university and is responsible for stewarding the long-term strategic direction, reputation and finances of the university.

- It approves the operating budget of the university, including tuition levels and financial aid policies.
- It manages the university's endowment and determines how much to pay out each year to support university operations, faculty salaries, and financial aid.
- It approves significant new buildings and major renovations of existing buildings, like Klarman Hall, Gates Hall, Cornell Health, and the new North Campus residential expansion.
- It elects the Cornell president.
- It also decides major policy matters, like whether to create a technology campus in New York City, a College of Business, a School of Public Policy, or a medical college in foreign countries, like Qatar.

In short, the board of trustees ensures that the mission, vision, values and reputation of the university live forever and remain true to our founding principles.

Appropriate and expected, you will note that ensuring and protecting the **'reputation'** of Cornell University is mentioned several times as a central duty of its Board of Trustees.

Conclusion and DEMAND Reiteration

Other than Mr. Leo Frank, whose true history of murder is now the focus of a pusillanimous effort of revision by the usual individuals, no other graduate has a record that is so substantially and provably dangerous to the **reputation** of Cornell University than Dr. Anthony Fauci:



But unlike the record of Mr. Frank, which involved the rape and murder of one innocent underage girl (and his putrid innuendo that an uneducated handicapped black man was to blame), **the criminal record of Dr. Anthony Fauci involves the horrific maiming and murder of millions worldwide.**

The evidence that Dr. Fauci was involved in the creation of the SARS-CoV-2 virus as part of his “*surprise outbreak*” and “*entity of excitement*” schemes; conceived / documented as early as 2012, is overwhelming.

Dear Dr. Fauci:

On February 13, 2023, we requested your testimony at a transcribed interview before the Select Subcommittee. On November 3, 2023, Select Subcommittee staff and your counsel came to an agreement to facilitate your testimony. That agreement is as follows:

- A transcribed interview to occur on January 8 and 9, 2024;
- Seven hours of testimony, excluding breaks, per day;
- Attendance by two personal and two government counsel; and
- A public hearing at a date to be named later.

As the former Director of the National Institute of Allergy and Infectious Diseases and Chief Medical Advisor to the President of the United States, you have knowledge pertinent to both investigating and evaluating the federal government's response to the COVID-19 pandemic but also preparing for future pandemics.
